LEGISLATIVE UPDATE:

REVIEW OF THE LEGISLATION BILL RS24521C1:

Summary of comments by Guy Hurlbutt

Although Trustee Hurlbutt will vote "yes" in support of the revised zoning bill (formerly HB 387), he does so with the following substantive reservations:

- 1. Although this bill is a substantial improvement over HB 387, it will likely encourage regional disputes within a community college district over time.
- 2. The proposed legislation is not in keeping with the existing law which encourages orderly development of community college districts within their respective service areas. CWI, for example, is in Area 3, consisting of 8 counties and a portion of Elmore County.
- 3. It places additional, substantial obstacles in the way of territories or counties seeking to join an existing community college district, including the requirement that a complete re-zoning on the entire district must occur each time a territory or county joins an existing district.
- 4. The language in the bill will likely result in one or more incumbent Trustees serving in the three community college districts from seeking re-election if their terms expire in 2016.

Despite these objections, Trustee Hurlbutt will vote to support the revised zoning bill because, having concluded that it will likely pass both the House and the Senate, he chose to work with the sponsors of HB 387 to correct legal and other defects in the first version. Having participated in these good faith negotiations, he feels it would be improper to not support the amended version.

Trustee Dunham:

Trustee Dunham appreciates that the legislators were willing to work with CWI and this bill is the best that we can do. He appreciates Senator Rice and Senator Brackett specifically and he appreciates their efforts as well. He is in support of this bill for several reasons, first we need to move on. For years this debate has been very divisive and my goal as a board member in July of 2007 was to help students and support economic development. Trustee Dunham believes that has always been his goal and this legislation has taken away a lot of resources. He would just like it to be over for the good of the college. He is very hopeful that all the voters in Canyon and Ada Counties will support a bond because that is his overarching goal.

Trustee Bastian:

Philosophically Trustee Bastian feels that people need to feel they are represented and it has been the tradition within public school zones, counties and other units of government that zones be created for people to feel that they have an advocate and a person that identifies with their particular area.

We can go all the way back to the approval of the Constitution of the United States and whether it should have been approved with a Senator for each state and representatives within districts of each state. In James Madison's article #10, he indicated that people would have particular interests for the specific area they reside in and they would promote and defend particular legislation or policies that would favor them. However, they would come into opposition against those that had different ideas.

Over time the best ideas would rise to the top and individual issues would fall away.

In a similar manner, CWI zones will enable trustees to promote particular interests that benefit their zones but these ideas may come into conflict with the ideas of other trustees and the best ideas will end up being approved. I think we will get Trustees that feel they have a vested interest in their particular zones and will also want to do the best they can for the college as a whole. I believe patrons will be less apt to say they are paying taxes and not being represented. Today there is pubic concern that, within the CWI district and other community college districts, there are areas that are not being represented. It is my hope that, with the passage of this legislation, the public will feel they are represented. It is for these reasons I am in favor of the legislation.
